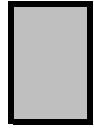

COMMINGLED MATERIAL

Material in plastic bags will not be collected.

- **METAL** cans should only consist of food and pet food types. Labels may remain on, and metal lids included.
- **GLASS** jars and bottles of all types and colors are acceptable. Labels may remain on, and metal caps included.
- **PLASTIC** bottles such as soda, juice, milk jugs, and detergent containers that are coded with numbers 1 through 7 are acceptable.
- **CLEAN ALUMNUM FOIL AND TRAYS** All commingled items must be rinsed to free them of food particles and residue. All material above should be combined together in Town issued commingle cart.
- **"GABLE-TOP" CARTONS** such as milk, cream, and juice are placed with other recycle containers made of metal, glass, and plastic for collection. Do not mix paper and cardboard recyclables.

PAPER/ CARDBOARD PULP

Material in plastic bags will not be collected.

- **NEWSPAPER** including inserts: May be bundled or placed in a container or box that can be emptied and left for reuse.
- **CARDBOARD** must be "non-wax" cardboard and free of excessive amounts of plastic adhesive tape. Staples need not be removed. It should be broken up and placed inside a container or cardboard box.
- **BROWN GROCERY BAGS** should be folded and placed inside of another kraft bag, or bag may be used to contain newspaper and junk mail.
- **MAGAZINES** consisting of envelopes, sweepstakes forms and office papers.

ALL MATERIAL MUST BE AT CURBSIDE BY 7:00 A.M.

BULK PICKUP

You must call the DPW office at (914) 989-1580 to schedule large or bulk items that do not fit into your garbage for collection. Limited to 2 - 3 large items per Bulk pickup request. 2 days notice required.

LARGE METAL ITEMS

Large metal items that do not fit into your recycling container including appliances, are collected on Tuesdays by appointment only. 2 days of notice required. Limited to 2 - 3 items per pickup request. For collection, you must call (914) 989-1580 to schedule large metal items for pickup.

COMPUTERS, TVs and ELECTRONIC WASTE

These items and more, including radios, coffee makers, small appliances shall not be placed in the garbage and must be brought to the Town Highway Yard for drop off, 100 Sprain Road between 7:00 AM and 3:00PM, M-F.

YARD WASTE COLLECTION INFORMATION

Mulch! Mulch! Mulch! The Town encourages mulching grass clippings and leaves - "Love 'Em and Leave 'Em". See www.leleny.org for more information about the benefits of mulching.

Organic yard waste is collected Monday to Friday at the curbside as follows:

- Grass clippings and other organic yard waste must be placed in biodegradable paper bags or open containers with weight not exceeding 50 pounds. No Plastic bags.
- Tree debris must be tied and bundled into lengths not more than four feet and width not more than two feet, or placed in an open container. The Town will **not** pick up tree trunks.
- The Town does not collect debris from private tree removals.

FALL LEAF COLLECTION

The Town encourages mulching of leaves. Bagged or contained leaves will be collected weekly during the fall leaf collection program. The Town no longer picks up leaf piles.

IMPORTANT INFORMATION REGARDING E-WASTE

- County regulations require mandatory recycling of all e-waste. Anything with an electrical cord is considered e-waste.
- Items for e-waste recycling can be brought to the Highway Garage (100 Old Sprain Road, Ardsley) weekdays from 7am to 3pm.
- Local retailers may accept e-waste regardless of the origin of purchase. Please check county website or call a retailer directly for further information.

WESTCHESTER COUNTY HOUSEHOLD MATERIAL RECOVERY FACILITY

The H-MRF accepts household hazardous waste and other items worthy of special handling from Westchester County residents on a year-round appointment-only basis. The H-MRF is located on the Grasslands Campus; 15 Woods Road, Valhalla, New York. Residents can reserve a time slot for appointments up to two weeks in advance. To make or cancel an appointment, call the Recycling HelpLine at (914) 813-5425. The Recycling HelpLine is available seven days a week from 9 a.m. - 7 p.m. For more information visit:

Frequently Asked Questions

•How do I dispose of paint cans?

You must call the DPW office at (914)-989-1580 to schedule a bulk pick-up for paint cans. Bulk pick-ups are scheduled for your second garbage day of the week and require at least 2 days prior notice to schedule. All paint must be either dried up using cat litter or a chemical paint hardener, or remaining paint can be poured onto rags to dry it up. Lids must be taken off and left to the side.

•How do I dispose of construction debris?

Construction debris (including cement) must be removed by a private carter or the contractor that did the work. Westchester County provides a list of licensed private transfer stations & processing facilities, which can be found at <https://publicworks.westchestergov.com/>.

•How do I dispose of Styrofoam? Is it recyclable?

Styrofoam can be placed outside with garbage.

•How do I dispose of household batteries and car batteries?

Regular batteries can be put out with the household garbage. Car batteries must be taken to a mechanic or gas station for disposal.

•How do I dispose of carpet?

Carpeting must be cut into 4 feet lengths, rolled and tied up, then placed out with the garbage. If there is too much carpeting to fit into your regular garbage cart for collection, you must call the DPW office at (914) 989-1580 to schedule a bulk pick-up. Bulk pick-ups for non-metal items are scheduled for your second garbage day of the week and require at least 2 days prior notice to schedule.

•How do I dispose of medical needles?

These items must be placed in a leak, shatter and puncture-proof container with a screw top and labeled "Sharps" and put out with regular garbage. For further information on disposal of medical waste, please refer to <https://publicworks.westchestergov.com/>.

•Are milk, juice, cream and "Gable- Top" cartons recyclable?

Recyclable cartons include both refrigerated "gable-top" and shelf-stable aseptic cartons, often used to contain:

- Cream
- Egg substitutions
- Juice
- Milk
- Non-dairy milk beverages
- Soup and broth

Place these types of containers with other recyclable containers made of metal, glass, and plastic for collection. They should not be included with paper and cardboard recyclables. These cartons need to be empty and rinsed before being placed in your commingled recycling cart.

•What to do with Wire Hangers?

Wire Hangers, like those from dry-cleaning are not accepted with household recycling as the wire can jam the machinery. The dry cleaner may accept them.
