COMMINGLED MATERIAL

Material in plastic bags will not be collected.

- METAL cans should only consist of food and pet food types. Labels may remain on, and metal lids included.
- GLASS jars and bottles of all types and colors are acceptable. Labels may remain on, and metal caps included.
- <u>PLASTIC</u> bottles such as soda, juice, milk jugs, and detergent containers that are coded with numbers 1 through 7 are acceptable.
- CLEAN ALUMNUM FOIL AND TRAYS All
 commingled items must be rinsed to free them of
 food particles and residue. All material above
 should be combined together at curbside in a
 container/box that will be emptied and left for
 reuse.
- "GABLE-TOP" CARTONS such as milk, cream, and juice are placed with other recycle containers made of metal, glass, and plastic for collection. Do not mix paper and cardboard recyclables.

PAPER/ CARDBOARD PULP

Material in plastic bags will not be collected.

- <u>NEWSPAPER</u> including inserts: May be bundled or placed in an open, reusable container that can be emptied and left for reuse.
- <u>CARDBOARD</u> must be "non-wax" cardboard and free of excessive amounts of plastic adhesive tape. Staples need not be removed. It must be broken up and placed inside an open, reusable container or bundled.
- BROWN GROCERY BAGS should be folded and placed inside of another kraft bag, or bag may be used to contain newspaper and junk mail.
- <u>MAGAZINES</u> consisting of envelopes, sweepstakes forms and office papers.

BULK PICKUP LARGE METAL & NON-METAL ITEMS

Collection of large or bulk items that do not fit into your Town issued garbage cart must be scheduled for a pickup by phone at (914)989-1580, or online at: https://widgets.recollect.net/r/area/GreenburghNY/waste?# Limited to 2-3 large items per pickup request. Items cannot be placed to the curb more than 24 hours prior to your scheduled pickup date. Any additional items placed curbside or items placed to the curb more than 24 hours prior to scheduled pickup dates may be subject to violation.

COMPUTERS, TVs and ELECTRONIC WASTE

These items and more, including printers, fax mahines, stereo equipment, etc. shall not be placed in the garbage and must be brought to the Town Highway Yard for drop off, 100 Sprain Road between 7:00 AM and 3:00PM, M-F.

YARD WASTE COLLECTION INFORMATION

Mulch! Mulch! The Town encourages mulching grass clippings and leaves - "Love 'Em and Leave 'Em". See www.leleny.org for more information about the benefits of mulching.

Organic yard waste (i.e. leaves, cut up and tied branches, as per the Town Code) is collected regularly - no appointment or call necessary. Just place your organic waste at the curb in open containers, or bundled and tied – no plastic! Please note:

- Leaves and grass clippings must be in paper yard waste bags or open, reusable containers not exceeding 50 pounds. No plastic bags. Consider mulching for improved yard care.
- Branches and twigs must be tied and neatly stacked in bundles less than 3 feet long and less than 2 feet in any other dimension. The Town shall not collect logs or stumps unless they are split in sections six inches or less in diameter.
- The Town does NOT pick up material from private contractors. For example, if you hire a contractor to remove a tree, they are responsible for hauling away the debris.
- The Town does NOT collect debris from tree removals, or gardeners renovating a property

FALL LEAF COLLECTION

The Town encourages mulching of leaves. Bagged or contained leaves will be collected weekly during the fall leaf collection program. The Town no longer picks up leaf piles.

IMPORTANT INFORMATION REGARDING E-WASTE

- County regulations require mandatory recycling of all e-waste, such as computers, TVs, printers, etc. Please refer to https://environment.westchester gov.com/residents/recycling-guidelines/electronics-monitors-tvs for further
- Items for e-waste recycling can be brought to the Highway Garage (100 Sprain Rd, Ardsley) weekdays from 7am to 3pm.
- Local retailers may accept e-waste regardless of the origin of purchase. Please check the County website or call a retailer directly for further information.

WESTCHESTER COUNTY HOUSEHOLD MATERIAL RECOVERY FACILITY

The H-MRF accepts household hazardous waste and other items worthy of special handling from Westchester County residents on a year-round appointment-only basis. The H-MRF is located on the Grasslands Campus; 15 Woods Road, Valhalla, New York. Residents can reserve a time slot for appointments up to two weeks in advance. To make or cancel an appointment, call the Recycling HelpLine at (914) 813-5425. The Recycling HelpLine is available seven days a week from 9 a.m. - 7 p.m. For more information visit:

Frequently Asked Questions

• How do I dispose of paint cans?

You must schedule a bulk pickup for paint cans. All paint must be either dried up using cat litter or a chemical paint hardener, or remaining paint can be poured onto rags to dry it up. Lids must be taken off and left to the side. Bulk pickups are available by appointment only and can be schedule by phone at (914)989-1580 or online at https://widgets.recollect.net/r/area/GreenburghNY/waste?#

• How do I dispose of construction debris?

Construction debris (including cement) must be removed by a private carter or the contractor that did the work. Westchester County provides a list of licensed private transfer stations & processing facilities, which can be found at https://www.westchestergov.com/swc/licensedprivate-transferstations-and-processing-facilities

• How do I dispose of Styrofoam? Is it recyclable?

Styrofoam can be placed in your Town issued garbage can or scheduled for a bulk pickup. Bulk pickups are available by appointment only and can be schedule by phone at (914)989-1580 or online at https://widgets.recollect.net/r/area/GreenburghNY/waste?#

• How do I dispose of household batteries and car batteries?

Regular batteries can be put out with household garbage. Rechargeable batteries must be brought to the Westchester County Household Materials Recovery Facility. Car batteries must be taken to a mechanic or gas station for disposal. The NYS Rechargeable Battery Law makes it illegal to throw rechargeable batteries in the trash. Rechargeable batteries must be brought to the Westchester County Household Materials Recovery Facility, located at 15 Woods Rd, Valhalla. Please contact them at 914-813-5425 to schedule a drop off time. • How do I dispose of carpet?

Carpeting must be cut into 4 feet lengths, rolled and tied up, then scheduled for a bulk pickup appointment. Bulk garbage pickups are available by appointment only. • How do I dispose of medical needles?

These items must be placed in a leak, shatter and puncture-proof container with a screw top and labeled "Sharps" and put out with regular garbage. • Are milk, juice, cream, and "Gable-Top" cartons recyclable?

Recyclable cartons include both refrigerated "gable-top" and shelf-stable aseptic cartons, often used to contain: cream, egg substitutions, juice, milk, non-dairy milk beverages, soup and broth, etc. Place these types of containers with other recyclable containers made of metal, glass, and plastic for collection: they should not be included with paper and cardboard recyclables. These cartons need to be empty and rinsed before being placed them in your commingled recycling cart.

• What to do with wire hangers?

Wire hangers, like those from dry-cleaning, are not accepted with household recycling as the wire can jam the machinery. The dry cleaner may accept them.
